NOTICE

1. The Undersigned is directed to inform all concerned that in terms of G.O No. 378-EH/1U37/2020 dated 27.06.2020 issued by the Principal Secretary, Department of Higher Education, Govt. of West Bengal the Final Semesters / Years Examinations, 2020 for both PG and UG students stand cancelled in view of COVID-19 pandemic. Instead, the concerned students shall be evaluated with 80% weightage to the best aggregated percentage of previous semesters / years and 20% on internal assessment.
2. The process for preparation of results for PG Final Semester Examinations, 2020 shall be initiated only after publication of Post Publication Reassessment results of PG First and Third Semester within **15th July, 2020** and the final semester results shall be declared by **31st July, 2020**.
3. (a) The examinees of PG terminal semester, 2020 are to be evaluated on 80:20 ratio, giving 80% weightage to the best aggregated percentage of the previous semesters and 20% on the basis of the best percentage obtained in the internal assessment of the previous semesters.

(b) Actual marks of the dissertation / term / internship paper shall be sent to the Controller of Examinations on or before **24.07.2020**.

(c) The back / supplementary papers will be evaluated on 80:20 ratio, giving 80% weightage to the best marks obtained in the previous semesters and 20% on the basis of internal assessment of the previous years.
4. The students in the terminal semester of Professional Courses like Law, Management and Teacher's Training shall be evaluated giving 80% weightage to the best of the aggregates of the previous semesters and 20% weightage on the basis of assignment based evaluation.
5. The portion of the academic session 2019-2020 affected by imposition of lockdown should be treated as "classes attended" by all the students / research scholars.

6. All students of the intermediate semesters shall proceed to the next higher semester. However, the students proceeding to the next higher semester will have to take admission to the next semester as per the existing rules.
7. The schedule of Ph.D. Course work and M.Phil. First Semester Examinations for the session 2019-2020 will be initiated in due course of time.
8. A special grievance cell w.e.f 11.05.2020 has been constituted at the University of North Bengal to deal with the grievances of the students related to the Academic & Examinations due to the prevailing pandemic situation under a mail box grievance.cell.covid19@nbu.ac.in
9. If a student wishes to appear in a formal examination instead of alternate evaluation method as stated above, he / she shall be given an opportunity to apply for the same through a process to be notified by the University. However, the said examination shall be conducted only after the situation gets normalized and the result of the said special examination will be published within one month of the examination held. The final result marks shall be revised as per the student's performance in the special examination, irrespective of whether he / she secured more or less marks than what was awarded to him/her through alternate evaluation method. To this effect, an undertaking will be obtained from the student for allowing him / her to appear in the special examination.
10. The next academic session 2020-2021 shall commence as and when the decision is communicated by the State Government when COVID-19 pandemic permits so.
